
SCHOOL STAFF

REMODELLED ASSESSMENT STRUCTURE 2017

The yearly outcome and the progress of the pupils during every academic year is evaluated through Terminal examinations and internal assessments. Internal assessments consist of periodic assessment, Notebook submission & subject enrichment which is evaluated throughout the year. The modern techniques and procedures of assessments are employed so that the assessments are by and large objective and reliable. In case of student's unsatisfactory turnout, remedial coaching is provided so that the students may take up their deficiency.

The promotion to the next higher class the following factors are strictly taken into account :-

- ★ A minimum of 75% attendance
- ★ A minimum of 33% marks in each subject in the school Terminal examinations

The decision of Principal in the matter of promotion will be final and irrevocable and cannot be challenged in any court of law. The school follows the remodelled assessment structure as per the direction by C.B.S.E.

MEDICAL FACILITY

For the treatment of general illness, the students are sent to the local Doctor. The parents/guardians are duly informed by the school and they shall bear the cost of treatment. In case of serious illness parents/guardians are duly informed to take their ward for the further treatment. While filling up the forms for admission, parents/Guardians are requested to disclose all previous known ailments and medications of their wards & produce medical fitness certificate issued by a competent Doctor not less than an M.B.B.S, failing which may result in refusal to take admission or expulsion if already admitted.



SCHOOL RULES

Parents/guardians are expected to observe all the rules and regulations of the school which may be enforced from time to time. In case of any dispute, the decision of the principal will be final and binding upon them.

* Throughout his /her stay in the school, A student will be governed by strict discipline of the school.

- * Smoking and consumption of alcoholic drinks in the premises of school are strictly prohibited, violation of it can invite severe punishment or expulsion from the school.
- * Students participation in all functions and activities of the school is compulsory.
- * All students shall converse in English during school hours.
- * All the students shall attend the school in prescribed uniform.
- Minimum 75% attendance in theory and practical are necessary for eligibility to appear in examination. It is the responsibility of parents/Guardians to find out from the Institute office the attendance of their wards from time to time.
- Any damage to the school property, caused by negligence or mischief shall be subjected to penalty. The quantum of such damage shall be determined by the principal for payment purpose from the defaulter.
- * Retention of any unauthorised materials (visual, digital etc.) is strictly prohibited within the jurisdiction of the school.
- * A student if found or caught with cell phone or other electronic gadgets then he/she would be suspended for 10 days and further if repeated then it may result to expulsion.

SCHOOL FEES

- Every parents/guardians has to pay the fees fixed by the school regularly and within time. The last date to deposit the fees is 15th of every quarter month. The details of fees can be collected from the accounts office
 - Parents/guardians are advised to deposit the quarterly fees in advance.
 - * The school fees are charged monthly rather than daily basis.
 - Fee once deposited is neither refunded nor adjusted in any case.
 - In case of non payment of fee till the 15th of the current month, the name of the student will struck off from the attendance register in the following month the fee of the previous and current month will be accepted along with a late fine of Rs.100 for each month default.

Admissions

In case the school fee is not paid consecutively for two months, the

name of the school will be enrolled only after payment of a sum of Rs.500 as a re admission fee, along with late fine of each month. Further information regarding fee charges can be collected from the school office.

WITHDRAWALS

- In case a student untended school without any information to the school authorities, his/ her name will be struck off from the school rolls after 15 days of absence. Moreover, any unauthorised absence of a student from more than 10 days after vacations considered to be a withdrawal from the school and the seat is thus declared vacant. Any unauthorised absence constitute an act of serious misconduct and strong disciplinary action will be taken against the defaulters.
- Parents are required to give one month prior information to the school for the withdrawal of their children but the school fee of the child would be collected for the whole academic session of that particular year. The transfer certificate is issued on the clearance of school dues only. If prior notice is not given, one month fee will be charged in lieu of it.
